The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.

Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.

Other conditions are contained in Annexure 'A' which is enclosed herewith.

Special conditions to be complied within three months:-

- The Extension of Provisional Affiliation up to Senior Secondary level w.e.f. 01/04/2016 to 31/03/2021. has been granted provisionally subject to the conditions that the school will Pay the pay scale and allowances which should at least be at par with corresponding categories teachers employed in government institutions of the State Govt. or as per scale prescribed in 6th Central Pay Commission of Govt. of India in respect of its teachers and will make payment by the school through ECS mode.
- The School Managing Committee has not been constituted as per Affiliation Bye-laws of the Board; therefore, it may be reconstituted by including 02 representatives each of teachers, parents and CBSE. The school is also required to forward 5-6 names of the Principals of the nearby CBSE affiliated school (2-3 of them may be from KVs / JNVs) for approval 02 of them as Board's nominees for inclusion in School Managing Committee.
- The number of students enrolled high in Class-IX and XII. Therefore enrolment should be maintained with optimum Number of 40 students in each section.
- The school is required to appoint more trained and qualified **PRTs and TGTs** Teachers to maintain section-teacher ratio as per norms and furnish a fresh staff statement accordingly.
- The school is also required to furnish valid **Sanitary Conditions, Drinking Water and Fire Safety Certificates** issued by the competent authorities.
- Number of books in the library is not as per Affiliation Bye-laws. As per norms there should be at least five books per child in the school library excluding text books, magazines, etc.
